- Care for children in medical or financial need or who have recently experienced a tragedy.
- Provide a valid Tax ID number.
- Complete all required Taggies, Inc. applications and product receipt forms.
- Provide information and valid documentation of their organization's purpose and function.
- Ensure that the donated product go directly into the hands of sick or needy children.
- Affirm the Non-Discrimination Policy for Taggies, Inc. Random Acts of Kindness Program. The policy is as follows;

All recipients of any donated support from any Taggies, Inc. charitable giving program must not discriminate on the basis of race, religion, age, gender, sexual orientation, national origin, disability, veteran and marital status.
